How do we store your data?

Fiit Consulting Sp. z o.o. securely stores your data at secured and encrypted servers located in Poland.

Fiit Consulting Sp. z o.o. would like to send you information about products and services of ours that we think you might like. If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Fiit Consulting Sp. z o.o. from contacting you for marketing purposes or giving your data to other members of the Fiit Consulting Sp. z o.o.

What are your data protection rights?

Fiit Consulting Sp. z o.o. would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

- The right to access - You have the right to request Our Company for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification - You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete information you believe is incomplete.
- The right to erasure — You have the right to request that Our Company erase your personal data, under certain conditions.
- The right to restrict processing - You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.
- The right to object to processing - You have the right to object to Our Company's processing of your personal data, under certain conditions.
- The right to data portability - You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
